PRESIDENT'S REPORT Dan Dickman

2023-2024 Annual Report

Dear Members of Faith,

Thank you for the opportunity to serve as President of your Congregational Council this past year! If you have an opportunity to serve on the Council or in some other ministry leadership position in the future, I highly encourage you to pursue that opportunity. I've been very impressed by my colleagues serving on the Council and in other congregational leadership roles and have learned and grown spiritually from my many interactions with them. I appreciate that opportunity!

In addition to its usual oversight duties regarding Faith's finances, property and ministry activities, your Council dedicated considerable time this year to assisting with several special projects. In most instances we did NOT do the heavy lifting associated with these tasks - several task forces and staff members took the lead in that regard - but we keenly followed and assisted when we could. Of note,

- The Columbarium task force made tremendous progress with project and landscaping design, fundraising, niche sales and more for a redesigned memory garden area and columbarium.
- The Human Resources Committee and senior staff collaborated with Council in (re)designing job descriptions and progressing through the hiring process for a new Director of Music Ministry, Administrative Assistant and Maintenance Specialist.
- A task force appointed by the Council drafted a new "Mission, Purpose & Core Values" statement for review by the Council and extensive discussions with the congregation. (Many thanks to Pastor Eric for leading MANY discussion sessions!) We learned a great deal about the numerous values we all share and some areas of scripture we interpret differently. Council continues to prayerfully discern appropriate next steps regarding the statement.
- Council developed a new Gift Policy for use when donors desire to make larger gifts to Faith. The
 policy clarifies how gifts will be used and includes provisions specifying how donors may direct the
 use of their gift if they so choose. We hope the new gift policy will enhance transparency and
 encourage members to consider legacy-type gifts to Faith as they plan for the future.

Thank you so very much to all the members of Faith who participated in these and other ministry activities this year! You truly do serve as God's hands in our world. My thanks go out in particular to those with whom I've served on Council these past two years. I've been blessed to serve with you!

Looking forward to next year, I'm pleased to report we have several *wonderful* proposed new members of Council as well as leaders of other ministries. Please join me in praying for God to bless and inspire them as they lead us forward.

I am excited for their leadership in 2024 as we continue to discern God's mission for us in this time and place and the core values we hold together.

I am thankful for the tremendous gifts of the staff: Pastor Megan Clausen, Kathy Evans, Jan Kirk, Stephen O'Baker, Caitlyn Reinders, Erik Ullestad, Jerry Waage, and Ruth West. I continue to be inspired by the partnership and ministry of Seeds of Faith Early Learning Center. Thanks to the directors, Jen Mauro and Christina Rostermundt, and the entire teaching staff.

As we welcomed Jan Kirk in July 2023 as Administrative Assistant, we bid farewell and Godspeed to Dr. David Johnson, Director of Music Ministry. Upon his departure, interim directors for the Chancel Choir, Jubilate Bell Choir and the Children's Choir were hired. I am incredibly grateful for the ministry of those who served in these roles: Matthew Harper, Stephen O'Baker, Trish Jordahl, Anna Harper and Keeley Taylor.

The Council appointed a Search Committee for the Director of Music Ministry in September. After months of interviews and discernment, the committee selected Mr. Zach Rohlwing. We look forward to Zach joining the staff no later than June 2024. I am grateful for the members of the Search Committee: Neil Hansen, Matthew Harper, Trudi Holst, Matt Huth, Susan Ihnen, Trish Jordahl, and Melissa MacGregor.

Among all those of the Faith community who died this past year, we continue to grieve the loss of Matthew Harper, who served as Interim Director of the Chancel Choir and a member of the Search Committee for Director of Music Ministry.

The Council established a process to discern Faith Lutheran's purpose and core values. A task force was appointed to draft a document for the Council to present to the congregation. Eight sessions on Sunday mornings and four sessions on Saturday afternoons provided an opportunity for the congregation to learn, engage in conversation and provide feedback. The Council will discern when and how the proposed draft will be presented to the congregation for a vote of affirmation. The draft document can be found at www.faithlc.org/council.

I am thankful for the members of the task force: Ken Cheyne, Paul Kolsrud, Becky Lachenmaier, Casey Miller, Laurie Politzer, Justine Stemper and Jill Waage.

As we continued to be church—worshipping together, growing in faith, serving those in need—there is always more to do. The world's needs only seem to be growing as we are faced with messages that tempt us to create divisions between us or avoid issues all together. Amid hard conversations, whatever the topic may be, we can be confident that our unity as a congregation is grounded in Jesus Christ. I am excited where God is calling us into the future; dreaming about new ways we can respond to the Spirit's calling to love and serve the world that God so loves.

Having served as Senior Pastor for five years, it continues to be an absolute honor, privilege, and joy to walk with the people of Faith in doing God's work with our hands, feet and voices. Thank you for continuing to love God, love our neighbors, and be the church together.

- The Altar Guild–for providing for the sacrament of Holy Community on a weekly basis and appointing the chancel with seasonal paraments.
- The musical ensembles—who week to week come together to rehearse and to be in community with one another to provide music for worship services, and for the interim directors listed above.
- Susan Ihnen—who has served as the main accompanist and music coordinator for Saturday worship during the interim. Thanks to all the musicians who have shared their gifts of music on Saturday.

YOUTH & FAMILY MINISTRY TEAM Pastor Megan Clausen

Youth and Family Ministry includes ministry with students in 7th grade through college and their families. We have also started adding our 6th grade students in where it is appropriate. I am grateful for your continued support, and energized by how the Spirit is moving in and among our young people and their families. It is my hope to continue to work to integrate our senior high youth into the life of the congregation and to continue building relationships with our young people, as well as being a support for their parents. Here's what we have been up to:

- Confirmation and Affirmation of Baptism: Confirmation this past year has been fantastic. For most of the year I taught the combined 7th and 8th grade class with help from our awesome small group leaders, while Dan Kuckuck and other parent volunteers led 9th grade students in the weeks leading up to the Affirmation of Baptism service. A 7th and 8th grade Confirmation retreat was held at the YMCA Camp in Boone this past September. We had a wonderful Affirmation of Baptism ceremony for our ninth-grade students on October 29, 2023. This spring, the 7th/8th grade students will be learning about the Gospels with Pastor Eric. "Pointed Questions" meets on Sunday mornings between worship services in The Point for junior and senior high students (6th-12th graders) to share in fellowship and faithful conversations.
- **Middle School VBS:** In June middle school students were invited to explore the building blocks of faith during the Build it Up VBS. We met for 3 afternoons of learning, art, fellowship, and service.
- **Middle School Palooza:** Twenty middle school students participated in the 2nd Annual Middle School Palooza on March 1st. We had a Carnival themed evening of games, snacks, crafts, and fun!
- **Baccalaureate**: Faith's 2022-2023 high school seniors were honored at our annual Baccalaureate worship service on April 30. A luncheon followed.
- **Mission trip to Nashville, TN**: In July, Pastor Eric, Alex Marske, Ann Drummond, Lezlie Mestdagh, Zoe Wood, and I led a group of 14 high school students to the YouthWorks site in Nashville. It was hot, but we spent time seeing the sights of Nashville, kayaking, meeting new people, serving at various sites throughout the city and growing in out faith. We look forward to the ELCA Youth Gathering this summer in New Orleans.
- **Senior High Youth Group** (SHYG): Throughout the year SHYG began meeting the 2nd and 4th Sundays of the month from 5-7pm. We made and ate dinner together. We played games, had theological discussions, and did service projects together. In the second half of the year, it was clear that Sunday evenings were hard for students to gather so we moved SHYG back to every Wednesday evening from 7:15-8:30 pm. We meet in the Gathering House to check in with one another, do service projects, play games, or have faith-based discussions.
- **College/Young Adult Connections:** In December SHYG sent almost 30 care packages to our college age students. They are always so appreciative of this connection their Faith community.
- Youth and Family Ministry Team: The Youth and Family Ministry is back up and running. Michelle Zimmerman, Caroly Petsche, Chad Thompson, Sarah Jefferson, and Kevin Stone all have graciously been serving on the YFM Team and we are learning together what this team does and can do. We are also listening closely for where God is calling us at Faith Lutheran.

The Children and Family Ministry team works with The Director of Children and Family Ministry, Caitlyn Reinders, to plan and execute ministry programs and events for children 6th grade and younger and their families. Through those events and programs, the team works to provide education, guide faith formation, build relationships, and equip parents and families to continue faith formation outside of the church building.

From last summer to this program year, we've had some new events and changes for CFM. In August we had our "Mac to School" event. After our 10:30 service we had a mac and cheese bar where we had a variety of toppings so everyone could custom make their own mac and cheese. All the free will donations from that went towards our Lutheran Lakeside scholarships for Faith campers. We also had a school supply drive for Crestview School of Inquiry. The whole congregation showed so much generosity in both aspects. Another big change we made was to our Milestone Ministry. One thing the staff has noticed about how milestones had been done previously, is that it was so hard to really dive into the topics of each milestone in the time allowed. We were also aware of families' busy schedules, and how hard it was if they were not able to attend when the milestone was only for one day. This year, we grouped most of them together and expanded the timeframe of the milestones to two- or three-week sessions. We wouldn't be able to do this without the help of our amazing volunteers who helped teach some of these milestones.

The CFM also welcomed two new members - Ginger Laidlaw and Amy Vowles. We are so excited to have them as a part of the team!

Throughout all the programs and events of Children and Family ministry, it couldn't happen without all the great volunteers who help everything run smoothly, as well as the participation of all our families. Thank you to everyone who has been involved in this ministry! Thank you to all who have contributed to our fundraising or offering efforts. In addition to our school supply drive in August, we had previously accepted donations as part of our Vacation Bible School that were directed toward Central Iowa Shetler and Services. Throughout the week, our families showed tremendous generosity. I was amazed with both collections that they were able to be transported in one trip. My car was filled to the brim each time! Also, a special thank you to the whole CFM team - Brad Burtnette, Mark Daniel, Ginger Laidlaw, Amy Vowles, and Piper Wolff. They have been a great support to this ministry.

In the coming year, we're looking forward to our summer programs, including hosting Vacation Bible School along with St. John's Lutheran in June. The summer is also a great time for us to get feedback from the program year so we can continue to create new events and programs for our families as well as update our current ones to fit their needs better. We look forward to seeing how that will shape our upcoming program year!

The Adult Faith Formation Ministry Team creates opportunities at Faith where adults will be immersed in life-long exploration and spiritual formation through experience, reflection, prayer, and study relevant to their needs, and equipped to live out their baptismal covenant as witnesses and disciples of Jesus in all areas of life.

This year, the Adult Faith Formation Ministry Team added two new members, Kristie Kolsrud and Holly Meagher, to our Ministry Team. We chose the seven-session series *Animate: Faith Practices* for Sunday morning study during the Fall term. Brian Turner and Becky Shaw led these sessions. Stephen O'Baker, Faith's organist, presented a session on Advent and Christmas music in December and another program on Lenten and Easter music in March 2024. The Adult Faith Formation Team also implemented the first of the adult Milestones programs for Adult Caregivers. These sessions were led by Pastor Eric Carlson and Rebecca Lachenmeier. Pastor Carlson also led the study *The Divine Drama*, an outline of the Biblical story line from Creation to Jesus the Messiah, on Wednesday evenings. In the Spring 2024 term, the church council led Sunday morning discussion sessions on Core Values at Faith. Additional adult learning sessions for this term will be led by Pastor Jack Mithelman and Pastor Dan Kuckuck.

We would like to thank Pastor Carlson for his insights and leadership with this Ministry Team as well as for his presentation of the Wednesday evening Bible study sessions. We also want to thank Brian Turner and Becky Shaw for facilitating the adult Bible study sessions on Sunday morning, Stephen O'Baker for sharing his expertise and knowledge of seasonal church music, Rebecca Lachenmeier for help with the Adult Caregivers milestone, and Erik Ullestad for his work in publicizing the adult faith formation events.

In the coming year, the Adult Faith Formation Ministry Team hopes to continue to offer more adult Milestones, create a space for parents of Sunday School children to gather for discussion and community building each Sunday morning, and to provide engaging faith-focused learning opportunities for adults at Faith, both on Sunday mornings and at other times during each week. We would also like to find a way to provide Zoom links for adult learning sessions that are offered, expanding the opportunity for more adults to participate in this learning.

We appreciate all the ideas they have shared, the help they have offered with fundraisers, their help in balancing our financials and for making Seeds of Faith a warm and welcoming environment. Our Preschool Board consists of Colleen Boyer, Nicole Faidley, Mallory Crispin, Kerri Grace, and Hillary Lindell.

Chapel

Each month the preschool children attend Chapel time in the sanctuary with either Pastor Eric or Pastor Megan. This is a time they all look forward to as they love singing songs, praying, hearing stories, dropping coins in the bucket for noisy offering and being blessed. We really appreciate the Pastors taking time out of their busy day to spend time with us and teach us about how God loves each of us.

Professional Development Goals

- 1. We have been fortunate enough to receive a grant from the state that we hope to use in making our space safer and more secure for our children and staff. We are going to investigate having secured doors put on both ends of the preschool hallway that would require a key fob for entry. We will also be looking at other ways to make our space safer from intruders which may include new windows in the hallway between rooms #101/105 and the preschool classrooms. Keeping everyone safe is of the upmost importance to us.
- 2. We are looking forward to our family event which will take place on May 5th from 4-6. We are praying for good weather and plan to have food trucks, a bounce house and lots of kid/family friendly activities to participate in. This has become a tradition for Seeds of Faith. We are excited to invite our families to come and spend time with the staff and make connections with other families. We pride ourselves on the community that is built from having a child attend Seeds of Faith. We hear that other preschools do not "feel" like Seeds of Faith. For that, we are grateful for all the teaching staff, board members and church staff that help to make our program stand out from all of the others.
- 3. With the wonderful weather we have had lately, we are anxious to get outside and plant our garden. We continue to make gardening part of our curriculum and we love the excitement the children have for planting a seed, caring for it, watching it grow, and then harvesting it. We often serve the vegetables that we harvest for snacks and the children love it! Several of the teachers applied for an agricultural grant from the state and ended up receiving it. MEMORIALS COMMITTEE Pastor Eric Carlson

The Memorial Fund is a valuable source of funding for the ongoing mission and ministry of the congregation.

Contributions are generally made in memory of a departed loved one, but a gift is also a fitting remembrance of other occasions such as a birthday, a wedding, an anniversary, or to honor a special person.

The Memorial Fund is a fund separate from current operating funds. It is administered by the Senior Pastor. Gifts are used according to the intent of the donor and the fund is subject to regular audit. A record of each gift is kept permanently on file at Faith Lutheran Church.

As of March 1, 2024, we have **\$4,197 of restricted gifts**. Areas of designation include: Altar Guild, Music and the Arts, Stephen Ministry, Memory Garden and Human Resource Training and Development.

We have approximately **\$14,503 of unrestricted funds**. Some donors have made suggestions as to the use of these funds, but have not restricted these as of yet. Some of the areas of suggested use include: the Endowment Fund, Children/Youth & Family Ministry, Family Promise, the Memory Garden and Music and the Arts.

Total contribution to the fund for FY24 = \$6,095 Total distribution for FY24 = \$19,688

The total amount in the Memorial Fund is \$18,700

Introduction: The Endowment Committee (Renee Wood, Tom Penningroth, Kevin Kruse & Ann Taylor) meets regularly with Pastor Eric to develop and grow Faith's endowment fund, review annual grant applications, and make distribution recommendations to church council.

Year in Review: In only its second year of grant distributions, Faith's endowment fund supported at least one project in each of the four possible ministry areas:

- Ministries of Faith Lutheran
- Scholarships for Faith members to attend ELCA colleges, universities and seminaries
- Local service agencies that align with Faith's mission
- The work of the Southeastern Iowa synod and the ELCA

Specifically, 2023 grant funds supported Lutheran Services in Iowa, Clive Community Services, Family Promise, the Southeast Iowa Synod, Nyame Do Women's Center, and two higher education scholarships. The committee continues to educate church members about the endowment and how they can continue their legacy at Faith through a gift or bequest. Information is available online on Faith's Endowment page, a printed brochure and discussed during learning sessions such as last fall's End of Life planning series. The committee also met with Mike Klinefelter, the ELCA's Regional Gift Planner for Iowa to discuss ways to grow the endowment fund. Long time Faith member Kevin Kruse joined the Endowment Committee in March 2024.

Gratitude: We're grateful for members of Faith who have made a legacy gift to the endowment or are considering a future gift. Many thanks goes to Faith's staff including Pastor Eric, Erik Ullestad and Kathy Evans for their guidance and administrative support, as well as the professional advice of Mike Klinefelter.

Looking Ahead: 2024 grant applications are under review with recommendations to the council expected by May. At least one small group educational session will be offered during the year. Finance Committee Members

Jane Turner (Treasurer), Kathy Evans (Director of Business & Finance), Brent Kell, Jeff Westendorf, Doug Lourens and Pastor Eric Carlson. This committee meets monthly; typically on the first Monday of each month. The committee's primary focus is financial analysis and planning additionally, ensuring an annual budget is prepared, monitored, and managed accordingly.

Financial Overview

Faith Lutheran has a June 30, 2024 fiscal year end. As a result, our comments here will focus on the congregation's financial position after eight months into the 2023-2024 fiscal year, or through February 28, 2024. Through February, congregational giving to operations is 110.1% of budget or up \$79,170, and general giving is up \$163,631 or 23.3% over the prior fiscal years' comparable months. Expenses are down at 89.1% of budget or \$87,308 favorable. The congregation has a total revenue plan (all sources) of \$1,294,729 and a "general giving" budget of \$1,201,774 for the year. Giving to general operations from Faith's membership represents over 93% of all income. Revenue other than general giving comes in the form of directed gifts for specific needs, rental income, and Seeds of Faith reimbursements. The expense favorability to budget is due primarily to lower than planned payroll expense; we created the expense budget with the assumption of a full-time, full year Director of Music Ministries and the current vacancy is being filled through interim personnel as well as a part time Maintenance Specialist that has yet to be filled. YTD net income is nicely ahead of budget due favorability on both the income and expense categories.

The church balance sheet consists of total assets of \$10,994,063 and total liabilities of \$874,098. The mortgage on the property as of February 2024 is \$837,023. Fixed assets (building, land, duplexes, etc.) total \$10,693,533 and represent 97.3% of total assets. Cash on hand and in the various funds totals \$300,530. Approximately 66.7% of cash on hand is in restricted funds primarily in the endowment fund. This leaves \$100,067 of cash on hand for general operations, down \$32,908 from the prior fiscal year. With the level of giving we have seen this year; it may seem odd that reserves are at this low level. Please see my note detailed below about how the reserves are being used to reduce our interest expenses. I want to express my great thanks for the insightful support that I have received from the Finance committee and in particular, from Kathy Evans. Her conscientious support has been key to our understanding, reporting, and managing the financial position of the church.

I also want to say a huge Thank You to our Faith community. Your generosity has put our general giving up by \$163,631 this year which is critical for the programming outreach work desired for our church. Thanks also go to each and every staff member for their diligent and conservative work managing expenses. We have been very fortunate again this fiscal year and it is my hope that Faith continues this as we go about the work of spreading God's word through our actions and contributions.

Current use of reserve monies

Background information:

In early 2023 as part of the committee's regular review of the financial statements, the committee recognized that the amount of Faith's reserves was at a significant level with no imminently needed draws on these reserves. The reserve balances were receiving a low level of interest income return because they were housed in our checking account.

Exploring Alternatives:

The committee discussed alternative means to increase our interest income by using these reserve funds in another investment vehicle, primarily in the form of short term CDs, understanding that funds would be unavailable until the CD term expiration unless the committee deemed it necessary to withdraw money from them earlier than the expiration term and thereby incur interest income penalties. Various combinations of three and six-month CD options were analyzed.

Solution:

After consulting with our bank representative about our goal of maximizing interest income by utilizing reserve monies, we were presented with the alternative of converting our church mortgage into a line of credit. Under this proposal, we could shift reserves against our indebtedness but would maintain the option to draw on the line of credit up to the former mortgage balance whenever needed. The interest rate on the line of credit would be the same as the mortgage. After analysis and discussion the committee agreed unanimously that this was the most income producing and flexible alternative. The necessary paperwork was signed in April 2023. Soon thereafter we transferred a substantial amount of reserves against the line of credit; approximately \$500,000. This amount at the end of February totals approximately \$600,000 and of this total, \$226,000 is restricted.

Current Outcome as of 2-28-24

In the ten months since we converted our traditional mortgage into a line of credit, we have recognized an interest expense benefit over budget of nearly \$13,000. In this same time period, we have not needed to increase our line of credit.
